TE – EU REACH Annex XVII Survey

Summary:


Annex XVII of Regulation (EC) No. 1907/2006 regarding Registration, Evaluation, Authorisation, and Restriction of Chemicals, also referred to as the **EU REACH Restriction List**, contains the list of restricted substances (on their own, in a mixture or in an article) for which manufacture, placing on the market or use is limited or banned in the European Union.

When substances are on the restriction list this not only impacts the use of those substances in products but also the use of the substance in the manufacturing processes (incl. maintenance and repair).

When you have received the relevant TE Connectivity Campaign email, you can respond to the open request by selecting it from your Supplier Portal landing page. Click the **start button**.

1. On the main page, review the **regulation details** and read the **instructions**. You can preview the survey by clicking the **preview survey** button and download the survey to review offline. This way you can make sure that you have all required information at hand before you get started.

REACH Restriction

This survey will provide detail regarding substances that the European Commission has restricted within the commerce of the EU. A restriction may apply to any substance on its own, in a mixture or in an article, including those that do not require registration, for example, substances manufactured or imported below one tonne per year or certain polymers. Restrictions are an instrument to protect human health and the environment from unacceptable risk posed by chemicals.

1) Before selecting any products below, please select the "Preview Survey" button and review the questions presented in the survey. The preview is available by download in order to view offline.

2) After reviewing the survey, if there are multiple products that would have identical answers for ALL questions within the survey, please select ALL of the products that would apply below and click "Declare x Selected Parts" to begin the survey.

As a result, suppliers may need to fill out the survey multiple times, once for each product, if answers will vary between products.
